

GOVERNMENT OF THE VIRGIN ISLANDS FORM III (a) THE IMMIGRATION AND PASSPORT REGULATIONS, 1982 APPLICATION FOR ENTRY PERMITS

NOTE:

- A. Applicants wishing to engage in gainful occupation is required to complete the whole form and to submit with this application the following:
 - a) Two (2) passport sized photographs with signature on reverse of prints of applicant and dependant under 18 years;
 - b) Police Certificate;
 - c) Medical Certificate dated not earlier than 30 days before application;
 - d) Written reference from previous employer;
 - e) Copies of any certificates of examination referred to in this application;
 - f) Letter from prospective employer with copies of newspaper advertisement with replies thereto and results of interview, if any;
 - g) Immigration Bond
- B. Applicant not wishing to engage in gainful occupation is requested to complete all questions except question 21.
 - a) Two (2) passport sized photographs with signature on reverse of prints of applicant and dependants under 18 years;
 - b) Police Certificate;
 - c) Medical Certificate dated not earlier than 30 days before application;
 - d) Two (2) testimonials of good character;
 - e) Immigration Bond;
